Campus Advocacy, Resources & Education (CARE) Graduate Assistant

The Graduate Assistant (GA) with TCU Campus Advocacy, Resources & Education (CARE) at Texas Christian University (TCU) is a part-time (9-month), 20 hour per week position. This position includes a stipend based on enrollment within the institution. The mission of the CARE office is to advocate and support students impacted by sexual and gender-based harassment, sexual assault, dating and domestic violence and stalking while promoting education and awareness that empowers lasting change in our community.

The office regularly provides confidential advocacy and support sessions with students; educational trainings and workshops for students on topics including sexual assault prevention and response, relationship wellness, stalking awareness and bystander intervention; support for the Journey to Healing survivor peer support community; management of all student compliance training in the areas of sexual assault prevention, alcohol and drug education, and diversity, inclusion and belonging; and campus-wide education and outreach programming in areas of sexual and relationship violence, sexual harassment, healthy relationships, stalking awareness and self-care.

The GA will receive proper training from the Campus Advocate as well as provided regular opportunities for continued education and training on campus and from community partners. The GA will be required to complete the Texas state certified confidential advocate training, provided by our community partner, The Women's Center of Tarrant County. This position may assist in providing outreach programs and trainings in residence halls or to Greek chapter meetings and other student organizations. Some night and weekend work is required.

This position reports to the Assistant Director of the Counseling and Mental Health Center – Campus Advocacy, Resources & Education. The GA position requires a high level of organization, enthusiasm for mental health and working with college students, knowledge of the issues of sexual and relationship violence (or willingness to learn), and the ability to work independently on tasks. This assistantship provides opportunities to think creatively and gain skills in advocacy support and prevention and response education. As an AA/EEO employer, TCU recruits, hires, and promotes qualified persons in all job classifications without regard to age, race, color, religion, sex, sexual orientation, gender, gender identity, gender expression, national origin, ethnic origin, disability, genetic information, covered veteran status, or any other basis protected by law.

Responsibilities/Opportunities: (including but not limited to)

- Assist in the development and implementation of awareness campaigns and prevention programming
- Collaborate in the research and development of educational workshops
- Assist with marketing and presentation of educational programming
- Provide staff support of the Journey to Healing Peer Support Community for survivors
- Attend staff meetings and educational trainings on campus and with community partners
- Manage the Sexual Violence Prevention Coalition
- Assist with content creation and management of the TCU_CARE Instagram account
- Opportunity to become a Texas state certified confidential advocate for sexual assault survivors
